This form is designed to comply with applicable land division ordinances and PA 591 of 1996 and PA 87 of 1997.

In order to process and approve a land division, the following requirements must be met:

- 1. Submit with application an official copy of the "Land Division Tax Payment Certificate Form" with approved signatures from county treasurer and drain office. This form can be obtained from the Allegan County Treasurer's office.
- 2. Each "resulting" parcel that is a "development" site must be "Accessible" as defined by Section 102 (j) (existing or proposed driveway or easement to public road).
- 3. Each "resulting" parcel that is less than 10 acres cannot have a depth to width ratio of more than 4 (depth cannot exceed 4 times width).

All other splits exempt under PA 591 and lot line adjustments are still required to complete the application but are not required to pay the split/division fee and the number of exempt divisions taken do not count against the number of State entitled divisions.

I realize that the owner splitting the original property can assign future divisions remaining to specific parcels. If no location of these "leftover" splits is designated they are automatically assigned to the remaining parent parcel created [see section 109 (2) of the statute.
