2007 Winter Tax Collection

Winter Tax bills will be mailed December 1st. Please check bill upon receipt. Corrections should be noted to the Assessor or Treasurer prior to the December Board of Review hearing.

The Treasurer will collect tax at the <u>Township Office</u> on <u>Tuesday (9 am. -12 pm.) and Fridays (9 am - 5 pm)</u> the months of December, January and February. A 3% penalty will be added to winter taxes paid after <u>February 14th</u>.

**Unpaid Summer 2007 tax can be paid to the Township Treasurer through February 28, 2008 (with added interest of 1% per month beginning September 2007)

December Board of Review will be held on December 11th, time will be posted in the near future.

CLEAN TEAM COMPLETES YEAR ONE OF SERVICE

The monthly Lee Township "Clean Team" has completed their first year of community service. Formed in 2006, it was a concern over the growing roadside trash problem and a desire to form stronger community bond that led the clean team to form. As a result, the 2-hour monthly pick up activity has resulted in much cleaner looking roads in the main areas of the township. The monthly clean up's take place from April through October and many truck loads of trash have been hauled to the recycle station.

Because of the number of regular participants we have only been able to keep the main drive-through areas of 109th and 56th picked up on a regular basis," says coordinator Donna Allgaier-Lamberti. "If we can attract more volunteers we can do a better job on the outlying areas." More volunteers are needed. This is community service opportunity for scouts, school or church groups, especially high school students who need volunteer hours to graduate. IF you are unable to participate in the monthly group clean ups due to health or work related issues, you may simply volunteer to keep the roadsides near your residence picked up and take that trash to the recycle station. The clean team asks that those who place garage sales signs at the corner of 109th and 56th, please remove them after the sale. FEATURED ARTICLE.....

In honor of the upcoming Veteran's Day holiday November 11th, resident Lester Rawson has researched and written an article about Lee Township Civil War Veterans.

The Civil War, Michigan and Lee

The American Civil War of some more than 140 years ago, had a profound effect on America that drastically changed our lives forever. This was the beginning of the income tax, other taxes, the banking system, the Federal Reserve, paper money and the expansion of the railroads just to name a few.

As I've toured civil war battle fields, I was awed by the huge monuments dedicated to Michigan soldiers involved in the war. At that time I became aware of the thousands of Michigan Soldiers of all races, even Native Americans that fought in the Civil War. This made me wonder if maybe we had some Civil War Veterans right here in our own little township of Lee.

Our cemetery caretakers thought there were, in the old section of the cemetery. So this past Memorial Day I spent some time in the old section to see if I could determine where those sites might be. I did discover a newer headstone placed beside a very old head stone with the inscription of one "David Dokey, a sharpshooter." His birth date could indicate that the years were correct for him to have served in the Civil War. Sharpshooter units were a part of the Civil War, as they were formed up on both sides through the war. They were both feared and respected.

I also discovered an unknown soldier headstone which surprised me, as unknown soldiers, those unidentified, were generally buried on the battlefield where they fell. He had a star near his headstone. I'm sure there is a story behind this gravesite.

I pursued my search for more information with the Allegan County Historical Society, which provided me with names of who to call for more information about the possibility of Civil War Veterans in our Lee Township Cemetery. I also learned that; yes, there were Civil War Veterans lain to rest at the Lee Township Cemetery and also that those stars did indicate that they were Civil War Veterans.

So, there is no doubt that we have Civil War Veterans in our cemetery and with this information it brings home to this very township the facts of involvement of our former citizens in the Civil War.

We can no longer think a long time ago, in a land far away, there was a civil war fought by nameless men. Those individuals who are resting at Lee Township Cemetery are a testimony to their and our community's involvement in that war.

These young men, in their time frame of history, participated in events that have forever changed the course of this great nation. So, one might say that during the great battles of that war, we were there....

David J. Dokey- Originally from Cassolopolis, Michigan. He enlisted in Company I of the 1st U.S. Sharpshooters on September 11, 1862 in Cassolopolis for three years at the age of thirty.

He fought at Blackburn Ford, Chancellors Ville, Gettysburg, Kelly's Ford, Mine Run, The Wilderness, Spotsylvania Court House, Cold Harbor, Petersburg and many other lesser known battles, after the war.

It is reported that he was involved in the lumber business for a time until his death. Perhaps more information will surface about Lee Township resident's involvement in the Civil War, but I'm already proud of those folks who were a part of our community and contributed to their place in history.
