

Winter Safety Tips from the Lee Twp Fire Dept

Be prepared for the winter heating season by

- testing your smoke alarms and carbon dioxide detectors
- having your chimney cleaned if you burn wood (creosote from smoke can cause a chimney fire)
- having a family evacuation plan with an outside meeting place in case of a fire
- not leaving electric heaters unattended
- cleaning out your dryer filters
- changing your furnace filter. This is not only a safety tip, but it can help you save on your heating bill.

LEE TOWNSHIP ROAD MILLAGE WORKING AS SUCESSFUL SUMMER REPAIRS ARE COMPLETED Submitted by Chuck Pugh

Four and a half miles of Township paved roads were repaired making these roads safer for all of us including the fire department, first responders, bused school children and law enforcement officers. These improved roads will also save residents on vehicle repairs. The paved roads that were tarred and chipped were 58th St, 105th St, and 103rd St. The first year of the three year millage paid for the repairs. In the Spring, the Township Road Committee will make recommendations to the Board regarding next year's paved and gravel road repairs. The recommendations will be based on present road conditions, protecting roads in fair condition, repair costs, and traffic volume. The worst paved road condition in the Township is 54th St from Lower Scott Lake to 112th. Gravel roads will be considered for drainage problems, using shoulder grading and new culverts. A renewal of the road millage will also be recommended to the board by the Road Committee to be placed on the Spring ballot. The present millage will run out in 2014, if not renewed.

The Lee Township Road Committee members are Les Rawson, Ray Russell, and Chuck Pugh. Let us know your suggestions (leave a message at the Township 236-6485). Thanks for supporting the improvements on our township roads.

2012 WINTER TAX INFORMATION

Tax bills will be mailed by December 1st. Please check your bill upon receipt for possible errors. Errors may be corrected at the <u>December Board of Review</u> scheduled for <u>Tuesday December 11th at 1pm</u> at the Township Hall.

The Treasurer will collect tax at the <u>Township Office</u> on <u>Tuesdays (9am – 12pm) and Fridays (9am – 5pm)</u> the months of December, January, and February. A 3% penalty will be added to winter tax paid after February 14th. <u>Payment must be received by due date, postmarks are not honored.</u>

Unpaid Summer 2012 tax must be paid at the Township (interest added 1% per month beginning September 15, 2012).

Beginning March 1, 2013, unpaid taxes (Summer & Winter) become delinquent and must be paid to the <u>ALLE-</u> <u>GAN COUNTY TREASURER</u>, with an additional 4% administrative fee and 1.5% interest per month. Verify the correct amount to be paid by contacting the County Treasurer's Office at 673-0260 or www.allegancounty.org.

Defer penalty and interest

Qualifying senior citizens or permanently disabled persons may defer penalty and interest on tax payments until April 30th for <u>Homeowner's Principal Residence only</u>. Notify the Township Treasurer to apply for a <u>Deferment</u> <u>Application</u> at the receipt of your tax bill.

AL-VAN HUMANE SOCIETY SERVICE TO LEE TOWNSHIP

Al-Van Humane Society continues to provide emergency shelter and care for animals in Allegan and Van Buren counties. The Lee Township board has an annual contract with the shelter for these services and in turn has given the shelter \$750.00 to subsidize the cost of caring from the animals from our township (an estimated cost of over \$8000 annually). In addition the donation boxes in Preferred Market and Pizza Plus have collected about \$300 a year for the shelter. Thanks to everyone's generosity the cats and dogs in our community are getting the help they need.

Saturday December 7th will be Al-Van Humane Society's Annual Open House. Come and tour to the shelter located at 73303 8th Ave in South Haven between 11am-2pm. You are encouraged to bring an item on their "Wish List" which helps tremendously. Did you know that in a year the shelter goes through 600 gallons of bleach, 15,000 lbs of cat litter, 9000 lbs of dog food and 5000 lbs of cat food. Top items on their wish list: cat litter, Purina dog and cat food, bleach, paper towels, large garbage bags, towels and blankets. 8 Steps to Cleaner Air and a Healthier Life for All

- Compost your leaves rather than burn them as burning leaves causes toxins to be released into our air and are harmful for pregnant women and the elderly or sick.
- Likewise, do not burn your trash (especially plastic bags).
- Compost food stuff (exclude meat, bones and grease) into wonderful soil for your garden.
- Recycle clean plastic bags at Wal-Mart or the local library.
- Don't burn instead recycle cardboard, metal, glass and newspapers at Lee Township Transfer Station.
- Re-use as many household goods as possible; give usable items to Goodwill or find an organization that can use your leftover paint and cleaning supplies.
- Commercial cleaning supplies are toxic. Use inexpensive vinegar mixed 50/50 with water for a solution that kills bacteria and leaves no harmful toxins in our air.
- Buy used or consume less... for less to throw away!!

Basic Smoke Detector Information

What is the single most important thing you can do when it comes to fire safety in your home? All experts agree that without a doubt, the most important step to take is to make sure you have working smoke detectors installed. Smoke detectors have saved literally tens of thousands of lives, and prevented hundreds of thousands of injuries over the years. They are cheap, they are easy to install, and there's absolutely no excuse for not using them. You can pick them up at discount stores, hardware stores, home improvement stores, and even more and more grocery stores carry them.

How many do you need? At a bare minimum, you need at least one for every level of your house. If all the bedrooms share a common hallway, then one detector in the hallway should do. But if the house is laid out with bedrooms separated in different areas, you will need one for each separate area. In addition, any bedroom where people sleep with their door closed should have a detector inside the room. Smoke detectors over ten years old should be replaced, according to fire safety experts. They also recommend you test your smoke detectors on a regular basis-say every Friday night or Saturday morning, whatever works for you, and is easy to remember. Testing them is very simple. Most smoke detectors have a button marked TEST, and you simply push it in. If the alarm sounds, it's fine. If it doesn't, either the detector has gone bad or the battery is worn out. In either case, you will need to fix it right away.

Because it is easy to forget about batteries in smoke detectors, it's become something of a national institution in America to replace the batteries twice a year, when we switch to and from Daylight Savings Time. That's a good idea, and you should adopt the habit. Many people have been lulled into a false sense of safety because "I've got a smoke detector." But if the batteries are dead, it will do you no good. Fire experts estimate that about a third of all detectors in this country have dead batteries in them. Don't let this happen to you. One situation that needs to be addressed is what happens if the smoke detector keeps going off for no reason? Usually this happens because it is too close to the stove, and steam and light smoke are setting it off. In that case, you will need to move it. Don't just take the batteries out to get rid of the annoyance. This can be a deadly mistake.

Deputy report: 92 complaints; 33 handled by our officer. Fire Department report: 2 calls for the month of May. Pancake breakfast during Pullman Pride at the fire station. First Responders report: 25 calls. Building report: 3 permits issued. Contract signed with PHP to move ahead with repairs to old church building. Transfer station report: collected \$548 and 62 tickets. Pullman Pride plans are underway for July 17th event. Newsletter will be out at the end of the week. Board of Review set for July 17th 6pm.
