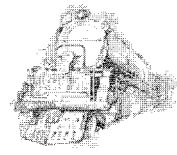

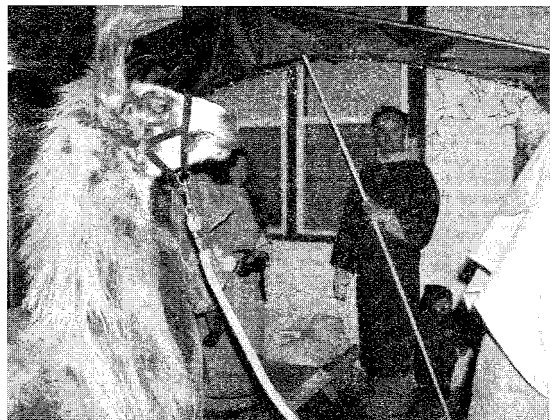

Thanks to everyone who had a hand in preparing and enjoying another beautiful holiday season! We hope 2007 is a happy and healthy year for all.

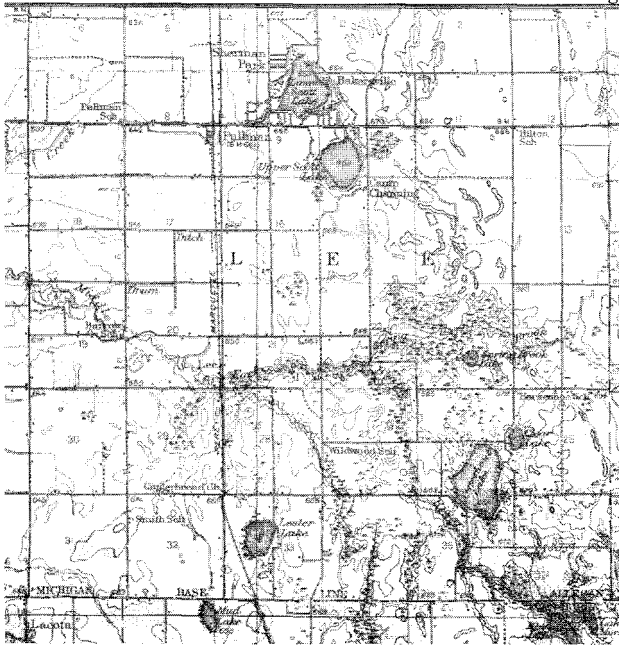

Bangor Quadrangle – 1927**

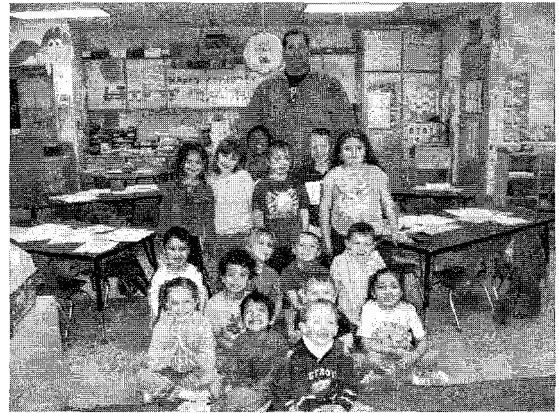

Re-Assessments

What's Bright Green and could show up on your doorstep?

Lee Township Assessor Doug Brousseau will be starting the re-assessment of the residential properties this spring. Residents should expect anyone from the assessor's team who comes to their home for the reappraisal to show photo identification. The assessment will include a viewing of the exterior of the home and any additional buildings on the property. Residents may be asked to let the assessor inside their home for a quick look around. If the resident is not home at the time, the assessor will leave a bright green note card at the door. Residents are to fill out and return to the address on the card. This is a large undertaking, but is required by the State of Michigan. Please help in completing this process in a timely fashion. Deputy Knapp will be missed, but we know he is on his way to a career move to better his talents and his County. We are proud to have had his services in our township and wish him the very best.

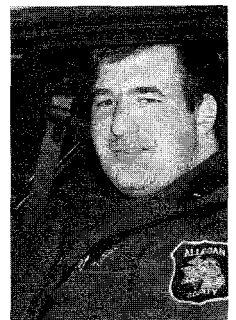
A New Face With Big Shoes to Fill

UPCOMING IMPROVEMENTS

Township Road Improvements for 2007-

Allegan County Road Commission has announced four major road improvements that will be made this summer. 1.) One additional mile of road will be improved on 60th Street, north of 102nd. 2.) Repaving will take place on 56th between 102nd and 109th Avenue. 3.) The construction of the bridge on 104th between 55th and 56th Street is anticipated to begin in March. 4.) The 109th culvert west of Pullman just before 58th Street will be replaced by the state due to a safety matter. In addition, the improvements of the primary road running from 48th and 104th to 56th and 102nd will be reviewed next year for possible placement on the county's 5-year plan.

Lee Township Regular Board Meetings Synopsis of Minutes

November 13, 2006

Board Comments: Clerk King stated that there was a very good turn out the General Election and everything went well. Clerk King announced that the December 11th meeting we will have a full board. Our new Supervisor John Schlack and elected Trustee Donna Christensen will be sworn in and be official for the next meeting.

Approved Motions:

✓Motions were made to approve the minutes from the October 9th meetings and also to accept the treasurer's report as presented.

✓Motion was made by King and seconded by Lowery to approve payment of the repair in the estimated amount of \$718.23 in the event that there is no warranty to cover the starter. Roll call vote was taken: Yes – Black, Lowery, King. Motion carries.

✓Motion was made by Lowery and seconded by Black to authorize Clerk King to publish the December Board of Review notice. Roll call vote: Yes- Black, Lowery, King. Motion carries.

✓Motion was made by King and seconded by Black to approve the Land Division as presented and approved by Assessor Brousseau for Yeske. All voted "Aye". Motion carries.

✓Motion was made by Black and seconded by Lowery to authorize the clerk to publish the notice for accepting snowplowing bids. Roll call vote: Yes – Black, Lowery and King. Motion carries.

✓Motion was made by King and seconded by Black to authorize payment for New Official Training for newly elected Supervisor John Schlack in the amount of \$107.00. Roll call vote: Yes- Black, Lowery and King. Motion carries.

✓Motion was made by Lowery and seconded by Black to purchase the upgrade for the accounting software in the amount of no more than \$200.00. Roll call vote: Yes- Black, Lowery and King. Motion carries.

✓Motion was made by King and seconded by Black to authorize Treasurer Lowery to submit the Tax Newsletter flyers to be printed for the Winter tax mailing. Roll call vote: Yes – Black, Lowery and King. Motion carries.

✓Motion was made by Lowery and seconded by Black to authorize payment of the bills with the additions of payment to the Cemetery Sexton and Allied Waste bills which came in after the bills were prepared along with the payment to the election staff for working at the November General election. Roll call vote: Yes- Lowery, Black and King. Motion carries.

Other information presented at the meeting:

Fire Department Report: 13 calls handled in Oct.. All radios have been switched. Chief DeWeerd announced the fire dept. received a DNR grant in the amount of \$1,350.00 to purchase forest fire equipment. The Chief requested that the board authorize payment of the replacement of the starter on the new fire engine. In the event the warranty does not cover the starter, Chief DeWeerd requested the board authorize payment for repair in the amount of \$718.23.

Building Official: \$68,000.00 in total improvements for October.

Transfer Station: \$505.00 collected for October with 58 coupons collected.

Lake Board: No dredging will take place for the next 2 weeks due to hunting season and the dredging process will end for the season on December 1st. Water samples have been taken and results found no arsenic.

First Responders: 27 calls for Oct -- 24 were medical and 3 were accidents.

Assessor Report: All the computer work has been completed. Board of Review will take place on December 12th.

Holiday Committee: The annual Community Social and tree lighting will take place on December 1st at 8:00 p.m.

Board of Review Appointments: In December the appointment for the Board of Review will be up for reappointment. Clerk King noted anyone interested in serving on the board of review submit in writing a letter of interest for next month's meeting.

December 11, 2006

Supervisor's Comments: Supervisor Schlack thanked the Holiday Committee for their wonderful job in decorating the town and putting on a wonderful holiday ceremony.

✓Motion was made by Christensen and seconded by Black to accept the bid from Dirtworks with proof of insurance and license for the contracted snowplowing. Roll call vote was taken: Yes – Black, Christensen, Lowery, Schlack and King. Motion carries.

✓Motion was made by Christensen and seconded by Black to sign the Bank Resolution by the Treasurer Jessie Lowery, Clerk Jacquelyn King and Supervisor John Schlack. Roll call vote was taken: Yes – Black, Christensen, Lowery, Schlack and King. Motion carries.

✓Motion was made by Christensen and seconded by Black to purchase the necessary software in the amount of approximately \$400.00 for the Official Lee Township website. Roll call vote was taken: Yes-Black, Christensen, Lowery, Schlack and King. Motion carries.

✓Motion was made by Lowery and seconded by Black to pay November's bills as presented with the addition in the amount of \$29.90 for the reimbursement of Santa wig and beard. Roll call vote was taken: Yes – Black, Christensen, Lowery, Schlack and King. Motion carries.

Other information presented at the meeting:

Deputies Report: Deputy Arnsman reported that there were 93 complaints for the month of November with 25 citations and no blight tickets were issued although the deputies had been out talking to residents concerning this issue.

Fire Department Report – 3 calls for November.

Building Official Report: No building or plumbing permits were issued. There were 10 electrical, 3 mechanical permits issued with a total of \$68,000 in improvements.

Transfer Station Report: \$366 collected for November with 59 coupons collected.

First Responders: 22 calls in November-- 20 medical, 1 accident and 1 fire assist.

Assessor's Update: The new construction portion of the re-evaluation should be finished in the next year.

Assessor also announced that the December Board of Review was to meet December 12, 2006 at noon.

Holiday Committee: Thanks to Pat's Excavating for all the work done in putting up the Christmas decorations. Thanks to Doug Bale & Debbie Laraway of Pizza Plus for the use of their facility for the social.

Board of Review Appointments – The previous BOR members to express interest were L. Rawson, E. Brock. The new individuals to express interest were S. Lacy and S. Miller

Discussion on old police vehicles – Condition of the cars was discussed along with if the tires were the newly purchased sets or not. Supervisor Schlack formed a committee to review all possible options in the disposal of vehicles. Supervisor Schlack stated he would post a time and date to when the committee would meet.

Commissioner's Report – Commissioner Babbitt gave his final county report.

January 8, 2007

Supervisor's Comments: Supervisor Schlack announced that he had done research on getting a PA system and will bring information forward for review in the future. He also announced that Deputy Knapp has accepted a position and will transfer out of Lee Township. He welcomed Deputy Greene who will take over this position.

Motions approved:

✓Motions were made to accept the minutes from the December 11, 2006 meeting and to receive the treasurer's report as presented.

✓Motion was made by Christensen and seconded by Black to authorize the Clerk to publish the sale of the two 2001 Crown Victoria's by sealed bid to be opened at the next board meeting. Roll call vote was taken: Yes – Black, Christensen, Lowery, Schlack and King. Motion carries.

✓Motion was made by Christensen and seconded by Black to have the awning repair completed. Roll call vote was taken: Yes – Black, Christensen, Lowery, Schlack and King. Motion carries.

Other information presented at the meeting:

Deputies Report: Deputy Greene stated there were 106 complaints filed. He also reported that during the COP's for Christmas program, 92 children (34 families) received clothing and presents.

Fire Department Report –10 calls for December.

Chief DeWeerd announced that the Fire Fighter I & II classes were going well. He also reported that a new 911 tower will need to be installed. Required physicals for all the Fire Department and First Responder Staff will be completed by April. This is estimated to cost around \$8,000.00

Building Official Report: \$1,197.00 total improvements for December.

Library Report: During the last quarter 77 books were loaned out.

Transfer Station Report: \$480.00 collected in November with 24 coupons collected.

First Responders: 31 calls in December-- 26 medical, 2 personal injuries and 1 fire assist. During the past year there have been 269 calls.

Pullman Pride Committee: Participation was encouraged for anyone who is interested in helping out for the 2007 Pullman Pride celebration.

Disposal of old Police vehicles – It was recommended by the committee to put the vehicles up for bid. The ad will be published in the paper and notices posted. Bids are to be sealed and opened at the next regular board meeting.

Repair of the Awning at the Township Hall- A estimate was given by JC Building to repair the awning at the cost of \$1497.00

Commissioner's Report – Commissioner Jessup handed out a newsletter to each citizen in the audience with a update on County business. He also passed out a card for everyone to fill out and rate what issues that felt were most important.

February 12, 2007 (unapproved)

Deputies Report: Deputy Greene reported 85 complaints taken in January of which half were handled by contracted deputies.

Fire Department Report –Dept. took 98 calls in 2006. The required physicals have been set up with Biocare and they will run 2 shifts to accommodate staff. A request was made for the purchase of 3 new sets turnout gear. The cost is currently \$1,550.00 each for a total of \$4650.00 and the price will increase if we wait until March.

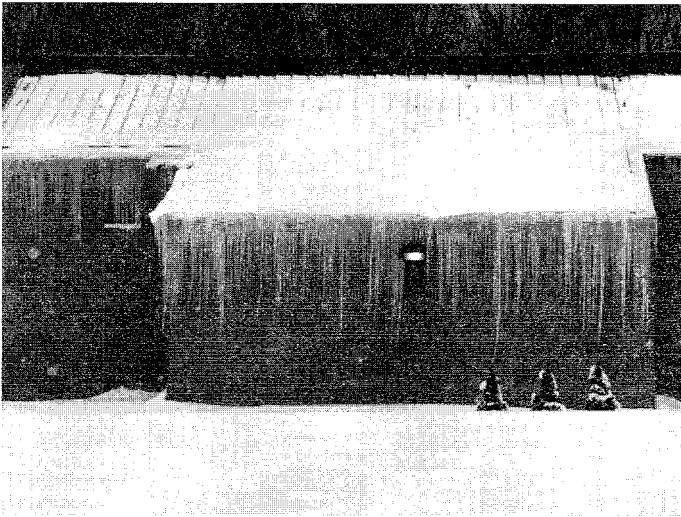
First Responders: 26 calls for January. Cheryl Irely and Sandra Kasinger resigned from the First Responder, due to physical strain. A written request was made by Albert Rawson to have Mary Fry do the continuing education and training for the next 3 years at the rate of \$500.00 per year for a total of \$1,500.00

Building Official Report: \$110,000.00 in total improvements for January.

Assessor's Update: The new construction and splits have been audited by the State. Ag, Commercial and Industrial classifications have been completed in the re-evaluation process and residential is to start shortly. The March Board of Review March 12th from 12 pm-6pm and March 13th from 3 pm – 9 pm.

Board Acceptance of the Water Bid Approval from State of Michigan The Board agreed to accept the state's decision and schedule the work with Compton's.
