#### **Meet One of Your First Responders**

My name is Ray Adams. I was a Chicago Fireman for 24 years. I returned and made Pullman my home and found out that there were only a handful of First Responders covering our Township. These First Responders all have full time jobs. They are willing to give up their time off to help the community. They are on call for 12 hour shifts, which means they cannot leave the township during that time. They only get paid \$12.00 if they are on call.

My wife and I decided that we wanted to help out our community. We went to classes and had to take a state test. We didn't realize the full dedication of commitment of these few First Responders until we were able to become First Responders ourselves. We just took for granted that if we needed medical help, it would be there.

As a First Responder, we are on the scene before the Paramedics and Ambulance can get to you or a loved one. We do what we have been trained to do, so that when the ambulance gets to you, you will ready for immediate transport to the hospital. Minutes do count!

The Township has a contract with AMR ambulance service , which is paid out of the First Responder's budget. If this millage doesn't pass, the funds won't be available to pay for the contract. Ambulance service will then have to come from whatever ambulance is available, which could be as far away as Holland or Grand Rapids. Remember, minutes do count!

First Responders are vital to the citizens in this township. Hopefully you will never have to make that 911 call. It is good to know that we will be first on the scene if you do. Last year we had over 200 calls. Could you be one of those callers?

First Responders will hold a meeting April 26th from 2 to 5 p.m. to meeting with citizens and answer questions.

#### This will be the language on the May 5th ballot. **FIRST RESPONDER MILLAGE PROPOSAL**

Shall the limitation on the amount of taxes which may be imposed on taxable property in Lee Township, Allegan County, Michigan, be increase by One Dollar and Fifty Cents (\$1.50) per thousand dollars (1.50 mills) of the taxable value for a period of five (5) years, 2009 to 2013, inclusive, as new additional millage to provide funds to Lee Township for emergency medical first responder services? It is estimated that 1.50 mills would raise approximately \$ 76,000.00 when first levied in 2009.

If you support and wish to continue the First Responders you will want to vote a "yes" vote. If you no longer would like to have the First Responders in our community than you would vote a "no" vote on May 5th.

#### First Responders Questions & Answer

- Q: Now that First Responders renewal has failed, what happen next?
- A: The board has three basic options: 1) Pay for the cost using township funds. 2) hold a special election to try to get the millage passed or 3) Leave township residents to manage an emergency on their own.
- Q: Was there an additional cost to the taxpayers on the 2008 Millage Program?
- A: No, this proposal would have replaced what was already paid with the previous millage..
- Q: Will there be a cost to the tax payers for option 1) Pay for the cost using township fund. In this case, the money would be taken from the budget which consist of property taxes and other fees. In the case of option 2) money would be provided by the millage in 2009-2013 budgets.
- Q: Why is the wording of the proposal so complicated and confusing?
- A: A special lawyer writes up the proposals to meet state laws and requirements. No one can make any changes to the wording.
- Q: Does the passing of this proposal cost me?
- A: No, this is not an additional tax. This replaces the tax that was already approved previously.
- Q: If the First Responders millage does not pass, will we be without emergency medical care in our township?
- A: Yes, After the AMR contract expires. If the board does not budget for the First Responders and does not schedule another public vote, then yes, the residents of Lee Township will be without emergency medical assistance except that which they arrange for themselves.
- Q: Where would the ambulance I need come from?
- A: Without the millage, 911 ambulances for Lee might have to come from Allegan, Holland, South Haven, Fennville, Coloma or Grand Rapids and could take in more than 40 minutes to get to the caller depending on which part of the township and the conditions of the roads at the time.
- Q: What if I elect to join an ambulance Membership Program?
- A: If you elect to join an Ambulance program it will cost you at least \$39.00 per year (if you have insurance ) or \$59.00 per year (if you have no insurance coverage.) It will be your responsibility to find which companies will cover your area and their cost.
- Q: I've heard that time is of essence in emergency medical care-- isn't 15 to 40 minutes the difference between life and death in a heart attack?
- A: Yes, in the event of a heart attack or stroke, minute wait time can be a real problem. Time is truly critical in the case of a heart attack. According to the American Heart Association, the sooner medical attention is offered the sooner the blood flow is restored. The goal is to prevent death of the heart muscle.

#### **KEEPING OUR COMMUNITY SAFE**

Have you heard of Neighborhood Watch? It is a national program that works locally when community members decide to actively become the "eyes and ears" of their community by notifying local law enforcement when they see or hear something suspicious. Cary Sue Ahlman started a local chapter in Lee Township in November 2008. The Neighborhood Watch committee meets the first Thursday of the month at 7:00pm at the Lee Township hall. Please try to come to a meeting to learn more about our efforts and how you can get involved. You can also purchase a Neighborhood Watch sticker for your home and/ or auto for \$5.00 by contacting the Township office or Cary Sue at 236-6279. ## SEPTIC SYSTMS VS. CLEAN CLEAR LAKES

The following information was gathered by resident Chuck Pugh to give everyone some awareness of how we may be affecting the environment.

There is an adverse effect septic systems have on the healthy conditions of inland lakes. The way that septic systems cause problems is that the nutrient laden water from drain fields or dry wells ends up in the lakes. Normally this septic water is filtered by many layers of soil before entering the underground water. In the case of septic systems being too close to lakes, the amount of soil available to filter the septic water is not adequate. The nutrient that is most problematic is phosphorus. Phosphorus is the main nutrient needed for plants to grow. Aquatic plants are no different from land plants. The more phosphorus in the lake water or lake sediment means more aquatic plant growth. Too many aquatic plants cause problems for a balanced lake environment, fishing and boating. As more septic phosphorus is added to inland lakes, year by year, very little leaves the lake water or sediment. Even if the lake has an outlet, there are very few nutrients that escape the lake. When the amount of phosphorus reaches a high level of concentration, not only does the lake water produce an abundant weed growth, but also algae blooms start to appear. An algae bloom is a biological growth that is suspended at the surface of the water and in abundance covers the surface with a greenish-brown, oily-looking scum. This algae scum, if it remains in the water for more than 3 or 4 days, gives off a very pungent odor. Once the phosphorus level of the lake reaches this point, it takes many years of active intervention to reduce the phosphorus to an acceptable level that would allow the lake to come back to a natural balance.

The septic drainage that causes most of the problems are the ones within approximately 200 feet or less of the lake shoreline. The absolute worst septic systems are the ones that are within a couple feet of the lake's water table. These systems are almost receiving no soil filtering and the nutrients are draining straight into the lake. The more use a septic system gets, the more nutrient-laden drainage is put into the lake. What can be done? Pump your septic tank. By pumping your septic tank you are reducing the level of concentrated nutrients from going into the drain field or dry well, therefore reducing the phosphorus going into the lake. Year round resident who use their septic systems more frequently should consider pumping their tank annually and summer only residents once every 5

resources in Pullman and the region for Pullman area residents. Initial plans involve establishing a Pullman office, pantries resources, a L.I.F.E. (Learning In Finances and Everyday Skills) Program and opportunities for community gatherings, volunteers, work projects and a building and property dedicated for outreach.

A collaboration involving Bravo House of Mercy, Douglas Christian Neighbors, We Care of South Haven, and Pullman area churches will work under the umbrella of Love INC of Northwest Allegan County to establish an office in Pullman. At the office, volunteers and staff will meet with people in need and make referrals to pantries in Pullman. These pantries are currently being connected/developed and will initially include food, personal needs and potentially clothing. We Care and Douglas Christian Neighbors have committed resources and support to help run the office and/ or supply the pantries. The group hopes to open the office by the end of May. The L.I.F.E. Skills Program is scheduled to begin in July.

The Love INC Pullman Office will use office space at the People Helping People building located at 943 - 56<sup>th</sup> Street in Pullman. People Helping People is a newly formed Christian community agency which will use the building and property for outreach in collaboration with ministries like Love INC and other groups, ministries or agencies.

The mission statement of People Helping People is to promote economic development, family health, physical health and spiritual growth, by providing services and activities that encourage and bring hope and wholeness to individuals and families. We partner with community leaders and agencies to promote the general welfare that produces faith and hope and opportunity for all.

Love INC, People Helping People, and the other ministries involved will be hosting an open house/informational meeting for the general public on March  $26^{\text{th}}$ , 7:00 - 8:30 pm at the People Helping People building (943 -  $56^{\text{th}}$  Street in Pullman). Meet the people involved, share needs, ideas, resources and make connections.

# Lee Township Regular Board Meeting Synopsis of Minutes

#### November 10, 2008 Regular Meeting

Motion was passed to approve the regular board meeting minutes from October 2008 meeting and treasurer's report presented by the Treasurer.

Motion was passed to purchase a generator for the Fire Department to run the lights of the rescue truck.

Motion was passed to authorize the folding machine lease from Pitney Bowles for \$117.00 per month for 36 months. Roll call vote was taken: Yes – Black, Christensen, Lowery, Schlack and King. Motion carries.

Motion was passed to purchase a table in the amount of \$300.00 to hold the new folding machine.

Motion was passed to have S. Miller work with Supervisor Schlack to have a PA system set up before the next meeting, not to exceed \$1,800.00.
