

# PULLMAN PRIDE SCHOLARSHIP

Fourteen years ago, Lee Township started Pullman Pride Day to celebrate our community and bring people out for a day of fun. From this day, funds raised were put in an account for the Pullman Pride/Lee Township Scholarship to be awarded to high school graduating seniors who live in Lee Township for continuing education. Two \$500.00 scholarships will be awarded in May. If you are a graduating senior, live in Lee Township and are interested in applying for this scholarship, please read the information below carefully.

#### Scholarship criteria:

- 1. Must be a graduating high school senior.
- 2. Must be a resident of Lee Township.

3. Please include a photo of yourself and a brief statement about your educational goals. Applicants must also complete an essay of at least 500 words that addresses: How has living in Lee Township impacted your life to date and how do you plan to make a lasting impact on your community?

## 4. Deadline for application is April 15, 2016.

Winners will be announced at awards nights or graduation depending on the high school you attend. Recipients will receive their monetary award after successfully completing one semester of college (which needs to be within one year of HS graduation). Proof of completion will need to be provided to the committee to receive your scholarship award money.

## ADDRESS SIGNS CAN SAVE LIVES

The Lee Township Fire Department would like to remind all residents that being able to locate your property in case of emergency (fire or medical) quickly can be the difference between life and death. Many residents have no address sign posted and others have the address on only one side of the mailbox. This limits visibility based on which direction an emergency vehicle is coming from. For just \$10 (the actual cost to make the sign) residents can have their house number made on a reflective green sign. "Our goal would be that everyone in the township have one. If someone is elderly, disabled, or just needs help with installation we can help with that. This is an important tool to help us find you," said Fire Chief Ted Chamberlain. Synopsis of Lee Township Board Meetings Minutes

#### October 12, 2015-Regular Board Meeting Minutes

Motions were made and approved for the following agenda items: to accept the regular meeting minutes from September 14 and to accept the Treasurer's report as presented; authorize the Clerk to pay the bills as presented with additions; and to adjourn the meeting at 8:30pm. Additional information presented: The board members extended their condolences to the family of Lester Rawson. Frank Baker, from the Allegan County Sherriff's Department, Candidate for 80<sup>th</sup> District Representative Mary Whiteford, Circuit Judge Marge Bakker and Rob Kengus, from the Prosecuting Attorney's Office all addressed the residents in attendance. Commissioner Jessup gave a county update on the old jail demotion, youth home, senior meal delivery program, and on clean-up at Lower Scott Lake. 112 police calls and 7 fire calls taken; first responders took 23 calls. Transfer station took in \$837 and 68 tickets. 6 building, 3 mechanical, and 6 electrical permits issued. The Trick or Treat hours will be set for 5 to 7:30 pm on Saturday, October 31st. Annual Winter Holiday Social will be Saturday December 5th at 6:30 pm.

#### November 9, 2015-Board Meeting Minutes

Motions were made and approved for the following agenda items: to accept the regular meeting minutes from October 12, and to accept the Treasurer's report as presented; to approve all 4 land splits presented; to opt out of processing dog licenses for the county; to authorize printing of tax newsletter; to publish December Board of Review dates; to adopt the recommended property hardship exemption at the20% increase and asset level at \$15000.00 per assessor's recommendation; to authorize the Clerk to pay the bills as presented with additions; to pay the election workers from Nov. 4<sup>th</sup> election; and to adjourn the meeting at 8:25pm.

Additional information presented: 7 fire calls and 15 first responders calls taken. Transfer station took in \$881 and 57 tickets. 6 building, 3 mechanical, and 6 electrical permits issued. The assessment has not been received from the Drain Office as of yet but should be somewhere around \$100,000.

#### December 14, 2015-Board Meeting Minutes

Motions were made and approved for the following agenda items: to accept the regular meeting minutes from November 9, and to accept the Treasurer's report as presented; to authorize the purchase of tires for patrol car in the amount of \$169.00 plus labor for each tire; to appoint Shirley Kay to fill the vacancy in the Board of Review; to approve land split for Bennish; to have the Supervisor as the FOIA Coordinator; to charge \$10.00 per hour or \$2.50 per 15 minute increments for research and processing the request. The charge for copies would be .10 per page and all mailing and postage fees would be charged; to adopt the resolution to transfer the ownership back to the county for the foreclosed properties; to authorize the Supervisor to attend the annual conference not to exceed \$1200.00 for conference and lodging; to authorize the Clerk to pay the bills as presented with additions; and to adjourn the meeting at 9:07pm.

Additional information presented: 78 police calls, 12 fire calls; and 19 first responders taken. Transfer station took in \$1000 and 50 tickets. 3 building, 2 mechanical, 3 plumbing and 5 electrical permits issued. Road Committee reported funding came through for 104<sup>th</sup>/ 48<sup>th</sup> and the Township will be responsible for \$35,000.00 per mile. Construction will be scheduled for 2017. Library Book Club always looking for new members. Bloomingdale HS science and mathematics class has been invited to go to Harvard.

#### January 11, 2016-Board Meeting Minutes

Motions were made and approved for the following agenda items: to accept the regular meeting minutes from December 14, and to accept the Treasurer's report as presented; for Fire Chief to put out for bids for the construction of a new fire engine to be purchased in 2017; to purchase a set of Good Year tires not to exceed \$2,000.00 for tires, mounting and balancing on first responder rig; to schedule a Special Meeting on February 8, 2016 at 6:30 pm for further discussion of Township 5 year plan; to authorize the Clerk to pay the bills as presented with additions; and to adjourn the meeting at 8:36pm. Additional information presented: 6 fire calls and 20 first responders calls taken. Transfer station took in \$875 and 33 tickets. 9 building, 2 mechanical, 1 plumbing and 12 electrical permits issued. Road repairs and costs were reviewed. Allegan County Road Commission meeting is scheduled for January 14<sup>th</sup>.
